## **RESOLUTION OF THE BOARD OF SUPERVISORS OF BRUNSWICK COUNTY APPROVING AGREEMENT TO PROCURE EMERGENCY COMMUNICATIONS SYSTEM**

WHEREAS, the Board of Supervisors (**the "Board"**) of Brunswick County, Virginia (**the "County"**) issued a request for proposals for the County to procure radio communications equipment (**the "Communications System"**) to support critical communications for first responders within the County;

WHEREAS, the Board received proposals from vendors in response to this request, negotiated with two or more vendors and has selected Radio Communications of Virginia, Inc. ("**RCV**") as the vendor that in the opinion of the Board has made the best proposal to provide the Communications System and provides the best value to the County and the Board has decided to award the contract for the Communications System to RCV;

WHEREAS, County representatives have negotiated and presented to the Board a Communications System Agreement (**the "Communications System Agreement"**) for the County to procure the Communications System from RCV.

### **BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF BRUNSWICK COUNTY:**

1. That the Board on behalf of the County hereby finds that RCV has made the best proposal to provide the Communications System and that such proposal provides the best value to the County, and the Board hereby awards the contract to supply the Communications System to RCV.
2. The Communications System Agreement is hereby approved in substantially the form presented to this meeting. The Chairman of the Board of Supervisors, Vice-Chairman of the Board of Supervisors and County Administrator, and each of them hereby is authorized to execute, acknowledge and deliver the Communications System Agreement and such related agreements, instruments and documents as are necessary to procure and provide for the proper operation of the Communications System, with any changes, insertions and omissions therein as may be approved by the authorized individuals executing the Communications System Agreement.
3. The County Administrator and her designees are authorized to provide notice to other vendors who submitted proposals to provide the Communications System of the Board's selection of and award to RCV to provide such Communications System equipment and the County Administrator is further authorized to reply in writing,

after consultation with members of the Board, to any response received from any such vendor to the notice of award.

4. This Resolution shall take effect immediately.
