**Re: FY18 Health Insurance Renewal**

Mrs. Keli Reekes stated The Local Choice renewal for Brunswick County results in an increase of 21.8% to the current rates. If the Board of Supervisors chooses to fund the program the same as it has in prior years, the total financial impact would be approximately \$167,000.

Mrs. Reekes stated that upon the direction of the County Administrator, staff solicited bids for benefits consultant services to assist the County with all health insurance related needs, to include finding savings in the current renewal. Three bids were received as follows:

- Bankers Insurance - \$16,000 annually
- BB&T Insurance Services - \$22,500 annually
- Gallagher Benefit Services - \$39,600 annually

The lowest bid was from David Rowe with Bankers Insurance.

Upon a motion by Mr. Zubrod, seconded by Mr. Jones, and unanimously carried, the Board accepted the bid from David Rowe, Bankers Insurance, in the amount of \$16,000 annually.
